## Solent Circuit 2021

### Notice of Race

Event dates:

17, 24, 31 October, 7, 14, 21 November

The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule.  
This changes RRS 60.1(a).

#### 1. Organising Authority.

1.1. The Organising Authority is the Lymington Town Sailing Club.

#### 2. COVID 19 & Government Guidance

- 2.1. It shall be the sole responsibility of the Yachts Owner, Skipper & Crew to comply with COVID 19 legislation on social distancing and related government guidance.
- 2.2. Each participating crew member shall agree to their details being recorded for the purposes of Track and Trace. The Yachts Owner, Skipper, or nominated Responsible Person shall maintain a crew list, updated for each race sailed, including crew name, e-mail and contact telephone number. The list shall be made available to the Organising Authority upon request, but only in the event of a positive COVID 19 case being reported.

#### 3. Rules

- 3.1. The event will be governed by the rules as defined in the Racing Rules of Sailing.
- 3.2. The Sailing Instructions may make permitted changes to any rules.
- 3.3. Racing will be conducted in accordance with the RYA Racing Charter and competitors are expected to conform to it. [RYA Racing Charter](#)
- 3.4. [NP] Boats in the Lymington River, while racing, proceeding to a race or returning from racing, shall not cause Wightlink ferries to take avoiding action.
- 3.5. [NP] All yachts in IRC and LAH Classes shall comply with World Sailing Offshore Special Regulations - Appendix B. (See NoR Attachment A for details).
- 3.6. For Nordic Folkboats there shall be no penalty for a breach of NFIA Rule 13.10 (Crew Limitations) and Nordic Folkboats are permitted to use spinnakers as per UK Class Racing Regulation Part II 1.4.
- 3.7. The J80 Class shall comply with their Class Rules, with local amendments where applicable.
- 3.8. RRS 52, Manual Power shall not apply.
- 3.9. In accordance with IRC Rule 22.1, boats rated with bunk cushions on board may remove the bunk cushions. No compensating weight need be carried.

#### 4. Advertising

- 4.1. Boats may be required to display advertising.

#### 5. Eligibility and Entry

- 5.1. Entries may be made on-line or by completing the entry form available at [LTSC Solent Circuit](#) Follow the link at the bottom of the page to the Online entry portal.

- 5.2. The event is open to the following classes:

- 5.3. The latest entry date for Whole Series Entries will be Friday 15<sup>th</sup> October 2021. Thereafter only Single Day Entries will be accepted.
- 5.4. If there is insufficient number of entries in either Class 1 or Class 2 and only one IRC class is viable, the lower rated competitors will be contacted to offer them the choice of IRC or LAH.
- 5.5. For entrants in the LAH Class, when the handicap of a boat is changed during a series, the boat shall not be compelled to change class after the completion of her first race.
- 5.6. When the number of boats entered in a class is below the minimum, boats may be re-assigned to another class or have their starts merged.
- 5.7. The Race Committee reserve the right to alter the ratings split between classes if less than six entries have been received in a particular class by the closing date or to balance class sizes. Final Class Splits will be posted as a Notice to Competitors by 0900hrs on Saturday 16<sup>th</sup> October.
- 5.8. A boat entering under the Lymington Adjusted Handicap Class shall have her TCC allocated from the last race of a Principal Series or event, or, if not having previously entered an event under LAH, from the LAH Base List. Boats not featured in the Base List will be asked to supply specific details so that a Base TCC can be calculated. Follow this link for more details on the Lymington Adjusted Handicap

#### 6. Racing Schedule

- 6.1. The event schedule will be:

6.2. The race schedule may be changed by the Race Committee to accommodate weather conditions or other circumstances. Changes to the advertised race schedule will be posted on the Official Notice Board, and by WhatsApp by 20:00 hrs on the day before the race day concerned.

6.3. The warning signal for the first race of each day will not be before 0925hrs.

## 7. Sailing Instructions

7.1. The sailing instructions will be available on the LTSC website on or about 1st October 2021.

## 8. Venue and Course Area

8.1. The venue will be the Lymington Town Sailing Club, Bath Road, Lymington

8.2. The course area will be The Western Solent.

## 9. Courses

9.1. Courses may be Windward / Leeward or Around the Buoys type.

9.2. Charts of racing mark locations and the letter, number or symbol designated to each will be available on the LTSC website and may be posted on the official notice board. The courses to be sailed will be described in the Sailing instructions. [West Solent Race Chart](#)

## 10. Penalty System

10.1. The sailing instructions will specify any changes to rule 44 and if Appendix P applies.

10.2. For breaches of any rule, other than a rule of RRS Parts 1 and 2, the protest committee may decide the penalty.

## 11. Scoring & Discards

11.1. RRS90.3 & Appendix A4.1 Low Point Scoring System shall apply.

11.2. The minimum number of races to constitute a series is two.

11.3. For IRC, LAH and Folkboat Classes the following discards shall apply:

## **12. Communications**

- 12.1. The Official Notice Board shall be on line at [LTSC Solent Circuit Official Notice Board](#)
- 12.2. VHF radio will be used by the Race Committee to communicate with competitors.
- 12.3. All boats shall carry an operational VHF radio at all times while racing.
- 12.4. For boats with class rules that prohibit the use of VHF radio, there shall be no penalty for breaching the class rule while complying with NoR 12.1 and 12.2.
- 12.5. The Race Committee may, in addition to VHF, communicate courses for each class and other announcements by WhatsApp. See NoR Attachment B for details of how to join the LTSC Solent Circuit Competitors WhatsApp Group.

## **13. Results & Prizes**

- 13.1. Results will be posted on the LTSC Website as soon as possible after completion of each race in the series.
- 13.2. Subject to outstanding protests, Final Results will be posted as soon as possible after the last race of the series on Sunday 21<sup>st</sup> November 2021.
- 13.3. Daily bottle prizes will be awarded for 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> placed boats in each class will be awarded. Where J80's have two scheduled races prizes may be combined.

## **14. Safety**

- 14.1. The personal flotation devices carried on board for each member of the crew shall conform to the requirements of World Sailing Offshore Special Regulations, Appendix B, Part B, Regulation 5.1.1. (See NoR Attachment A)
- 14.2. The race organisers shall not be liable for any loss, damage, death or personal injury howsoever caused to the owner/competitor, his skipper or crew, as a result of their taking part in the race or races. Moreover, every owner/competitor warrants the suitability of his boat for the race or races.
- 14.3. A boat that retires from a race shall inform the race committee as soon as practical, either by VHF, WhatsApp or telephone.
- 14.4. No boat shall race with an anchor protruding over its bow.

## **15. Support Boats**

- 15.1. Support boats may be subject to restrictions that will be detailed in the Sailing Instructions.

## **16. Risk Statement**

- 16.1. Rule 4 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone." Sailing is by its nature an unpredictable sport and therefore involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:
  - a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
  - b) They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;
  - c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
  - d) Their boat is in good order, equipped to sail in the event and they are fit to participate;
  - e) The provision of a race management team, patrol boats, umpires and other officials and volunteers by the organiser does not relieve them of their own responsibilities;
  - f) Their boat is adequately insured, with cover of at least £2 million against third party claims.

## **17. Amendments to the Notice of Race**

17.1. This Notice of Race may be changed by a notice posted on the Official Notice Board.

## **18. Official Event Photography & Drones**

18.1. During the course of the series official photographers may be in attendance. Drones (UAV's/UAS's) may be used in close proximity to obtain media for the event. This may be on land and / or over water. By entering /participating in the series you agree to their use unless you register any objection prior to the series with the organisers. Any material gained from their use can be used by the organisers or sponsors for PR and Media purposes.

## **19. Further Information**

Competitors are welcome to use the LTSC Clubhouse facilities and bar on each Sunday of the series. The Solent Room and Lower Deck bars will be open, with limited Social Distancing restrictions in place. A marquee with outside bar may be erected on the lawn.

## Notice of Race - Attachment A

### WORLD SAILING OFFSHORE SPECIAL REGULATIONS - Appendix B

SPECIAL REGULATIONS for Inshore Racing Special Regulations for inshore racing are intended for use in short races, close to shore in relatively warm and protected waters where adequate shelter and/or effective rescue is available all along the course, held in daylight only.

All the items relevant to Special Regulations for inshore racing are shown in Appendix B.

#### Part A Basic - The following regulations shall be observed:

##### Regulation

- 1.02. Responsibility of Person in Charge
- 1.02.1 Under RRS 4 the responsibility for a boat's decision to participate in a race or continue racing is hers alone. The safety of a boat and her crew is the sole and inescapable responsibility of the Person in Charge who shall do his best to ensure that the boat is fully found, thoroughly seaworthy and manned by an experienced and appropriately trained crew who are physically fit to face bad weather. The person in charge shall also assign a person to take over his/her responsibilities in the event of his/her incapacitation.
- 2.03.1 All equipment required by OSR shall:
  - a) function properly
  - b) be regularly checked, cleaned and serviced
  - c) when not in use bestow in conditions in which deterioration is minimised
  - d) be readily accessible
  - e) be of a type, size and capacity suitable and adequate for the intended use and size of the boat.
- 3.02 Watertight Integrity of a Boat:  
A boat shall be essentially water tight and all openings shall be capable of being immediately secured. Centreboard, dagger board trunks and the like shall not open into the interior of a hull except via a watertight maintenance hatch with the opening entirely above the Waterline

#### Part B Portable Equipment – The following shall be provided:-

##### Regulation

- 3.23 One strong bucket with a lanyard and of at least 9 litres (2.4 US Gal) capacity
- 3.24 One compass (a hand-held is acceptable)
- 4.05 One fire extinguisher required if electrical system, engine or stove on board
- 4.06 One anchor
- 4.22 A lifebuoy with a drogue
- 4.22.5 A heaving line, no less than 6 mm (1/4") diameter, 15 - 25 m (50 - 75') long, readily accessible to cockpit
- 4.25 A strong, sharp knife sheathed and securely restrained shall be provided readily accessible from the deck or a cockpit.
- 5.1.1 Each crew member shall have a personal flotation device which shall:
  - (a) be equipped with a whistle
  - (b) clearly marked with yachts or wearers name
  - (c) if inflatable, regularly checked for air retention,Unless otherwise specified by a boat's applicable class rules or by sailing instructions, personal flotation devices shall have at least 150N buoyancy, arranged to securely suspend an unconscious person face upwards at approximately 45 degrees to the water surface.
